Don Babb, TCCA O&M Chief, reported on the following O & M activities: Road grading around Funks Reservoir and to check 18; Buring drain ditch Road 69 to Waste Way; Debris removal around shoreline of Funks Reservoir and Funks Dam spillway; Drain cleaning at Funks Reservoir; Reinstalled LaGrande meter 77.62L; Gravel access road Walker creek; Fence repair Walk creek siphon; Teton treatment on April 22nd at check 1 and check 16; Install new buoy lines at check

21 and Cortina creek siphon; Checking grates; Close and seal gates in Corning, it is up and running; Screen cleaner maintenance, greased, cleaned, and inspect; TCCA assists with Salmon feeding; Log boom maintenance, replace cables; Change out AC filters on 6-ton units, Red Bluff Pumping Plant; Cleaning out ditch along West Canal Road; Fence repairs on TC Canal; Wash and install fish screens, section 3 and 4; Finish spraying both canals; Repeater site visit; Currently pumping 400CFS; vehicle and equipment maintenance; Meter readings; Safety meetings. Upcoming activities: Continue road grading Funks Reservoir to check 18; Road grading Road 69 to Funks Reservoir; Check structure yearly maintenance; Replace moss decks OAWD 5 and GWD 2; Slough repair in check 13; Road grading Road 35 to Hwy 162; Continue working on erosion and tree removal on Corning, 2024 reviews; Mechanical repairs and services as needed; Inspections and maintenance of TC and Corning canals, Red Bluff office complex and pumping plants; Thinking about switching RB phone lines to VOIP; Install more fish screens in the river; Treating the Corning and TC canals; Work on Corning canal and pumping plant recommendations from USBR.
