Don Babb and Aaron Hall, TCCA O&M Chief and Red Bluff Supervisor reported on the following O & M activities: Bathtub cleaning Hahn Road; Vehicle repairs; Haul equipment to BidCal for auction; Copper treatments on TC & CC canals; Shaft removal check 10 gate 2 for repair; Road grading; Smoke tests trucks 31 & 36; Recalibrate check 9 upstream elevation sensor; Power out due to Repeater

backup generator failure; Flushing undershoot tubes Evans Road; Cleaned out sediment jetting pump filters; TC operations and patrol to check 9;Trimmed trees on Corning canal; Replaced burnt bulbs on fish screen deck, lighting; Replace motor and break, check 5 Corning canal; Reprogramed PCL check 22; Cleaning trash racks at pumping plant; Unwire and pull motor 9 and sent out for repairs; WAPA replaced transformer pole feeding check 1, TC canal; Currently pumping 375CFS; Meter readings; Safety meetings. Upcoming activities: Continue grading; Drain repair end of canal; Bathtub cleaning; Drain cleaning; Continue working on erosion and tree removal on Corning, 2024 reviews; Mechanical repairs and services as needed; Inspections and maintenance of TC and Corning canals, Red Bluff office complex and pumping plants; Cleaning vegetation from trash racks at pumping plant; Motor #9 return and motor #4 out for repairs; Work on Corning canal and pumping plant recommendations from USBR; Pulling out fish screens and pulling oil samples from motors.

#### **GENERAL BUSINESS**

# Policy Updates-Focus on Assessment and Reserve Related Policies (9060, 9070, 9075, 9080 and 9085)

A. Manager Vanderwaal discussed the proposed policy 9060 spells out how annual assessments for the member districts are calculated and when they are due, the process is set forth in the JPA By-Laws and in Resolution 2019-01.

Manager Vanderwaal discussed policy 9070 which describes the various Reserve Accounts and sets the target level for each. The only substantive change is the recommended update to the Reserve target for the USBR Emergency Reserve Fund to meet the required percentage of annual budget over the most recent 3 years.

Manager Vanderwaal discussed policy 9075 which describes the rebuilding schedule for non-restricted Reserve accounts and had no recommended changes.

Manager Vanderwaal discussed policy 9080 which designates how interest accrued will be distributed. The previous policy referred to non-existent Reserve accounts, and the proposed update designates a method for distributing the interest funds based on the expected demands of carrying out the Strategic Plan and Capital Improvement Plan.

Manager Vanderwaal proposed policy 9085 to update how end of the year budget surplus is presented to the Board for distribution; it changes from the Budget committee to the General Manager calculating the surplus and bringing it to the full board for deliberation.

## **Discuss and Consider Sties Reservoir JPA Activities**

**B.** Manager Vanderwaal reported Sites Project has begun negotiations for their Benefits & Obligations contract on September 8<sup>th</sup> and 9<sup>th</sup>.

They provided site visits to the Construction Manager at Risk (CMAR) candidates in late August.

Director Traynham and Director Urkov reported on Zone 3.

## **Authorization to Enter Contract with USBR for Reconciliation Projects**

C. Manager Vanderwaal discussed to consider authorizing Chairman Dennis and/or Manager Vanderwaal to enter into a funding agreement or contact with the USBR to execute the proposed projects from the Reconciliation Bill funding. The TCCA has proposed three projects (Red Bluff Pumps, Canalside Screens and Corning Pumping Plant) to be funded by the Reconciliation Bill and the USBR is working its way through the process to determine which projects it will fund nationwide.
