Operations & Maintenance

A. Don Babb and Aaron Hall, TCCA O&M Chief and Red Bluff Supervisor reported on the following O & M activities: Copper treatments on Corning and TC canals; Erosion repair end of canal (Tim Doherty property); Undershoot drain flushing at Evans Road; Painting mile maker numbers on bridges and check structures; Replace elevation probe check 24; CCWD gravity meter trouble shooting and

repair; Close gate 1 at Dunnigan #4; Replace air bags Truck #32; Vehicle oil changes and maintenance on equipment; TC operations and patrol to check 9; Grading roads on Corning Canal; Trimmed trees around Red Bluff office; Started pulling out fish screens, section #2 done; Crane repairs; Repaired gate and fence at Samson Ave., Corning Canal; Cleaning trash racks at pumping plant; Prepare motor #4 for removal; Pulled and cleaned pumping plant flow meter; Currently pumping 200CFS; Meter readings; Safety meetings. GENERAL BUSINESS

<u>Policy Updates-Focus on Public and Policy Complaints, Claims, and Public Documents</u> <u>Policies (1030, 1040, 1050, and 1060)</u>

A. Manager Vanderwaal discussed the proposed policy 1030 spells out how public complaints are to be managed within the Authority. The proposed changes change the responsibility process from outdated positions to the General Manager.

Manager Vanderwaal discussed policy 1040 on details of how property damage claims against the Authority are processed and who is responsible. Proposed changes to update positions named and update the cost limitations.

Manager Vanderwaal discussed policy 1050 on how it outlines the Authority charges for copying fees. Proposed changes are only updates to the cost of copying documents.

Manager Vanderwaal discussed policy 1060 on how it addresses complaints regarding how policies are managed. Proposed changes to update the position name and responsibility level.

Discuss Draft 2026 TCCA Budget

B. Manager Vanderwaal presented and summarized the details of the proposed 2026 Draft Budget as recommended by the Finance Committee to the Board of Directors, and the ultimate presentation will be at the November Board Meeting. Director Traynham brought up the issue on the Insurance, seemed to be more than normal. Manager Vanderwaal will investigate that line item and provide a detail explanation to the board of directors via email prior to the November board meeting.

<u>Discuss and Consider at Least 2 Board Members to Attend Virtual Board Compliance Training Hosted by GSRMA</u>

C. Administrative Officer Dicharry presented and discussed with the board as part of the Risk Management Accreditation Program (RMAP), GSRMA offers training for directors. This request is one of the annual requirements for the rebate program, RMAP. The Board may consider designating two of its members to attend the virtual training. After further discussion it was determined that Director Jim Jones and Director Shandon Smith would be the two members to attend the Virtual Board Compliance Trainings.

Annual Water Transfer Document Preparation

D. Manager Vanderwaal discussed with the board to consider authorizing Manger Vanderwaal to direct the start of preparation of water transfer documents. Each year the TCCA member districts have begun the preparation of water transfer documents in case of fallowing or groundwater substitution transfers are needed. The costs are usually divided by quantity of water requested in the transfer and are usually minimized by stopping the work as early in the process as possible pending the forecasted allocations.

E. Manager Vanderwaal reported Sites Project CMAR selection is underway. They expect to receive 3 proposals in mid-October with interviews in early November and final selection by November 21st JPA Board meeting with negotiations to follow that.
